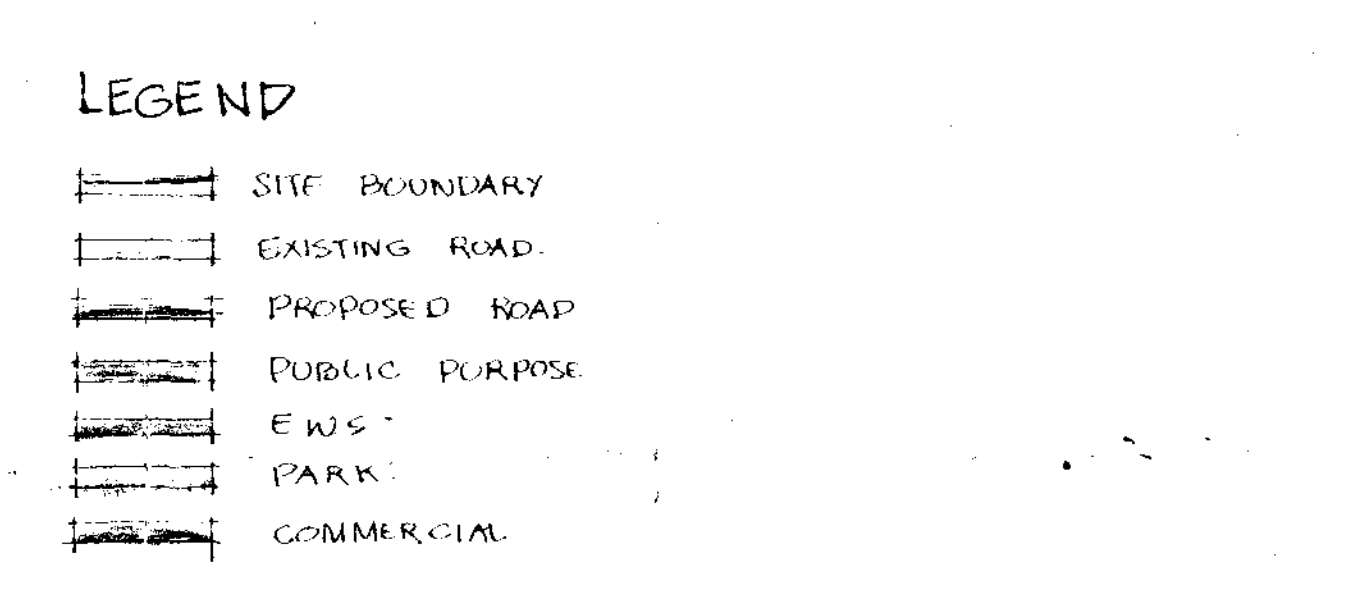
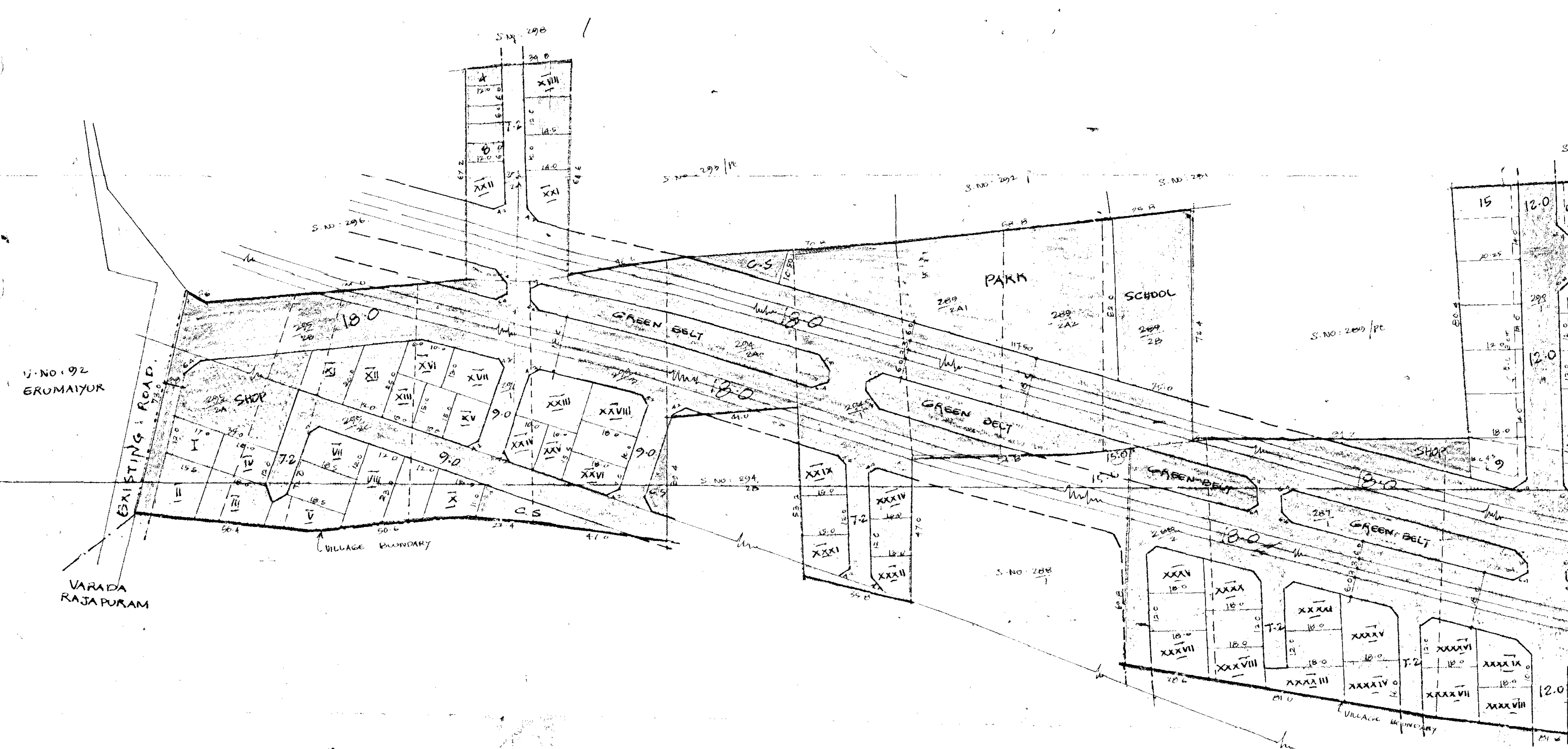

- CONDITION
1. THE AREA earmarked for public purpose (I to E) [USE AND DIAGRAM OFFICE, STAGE STATION ETC.] SHOULD REMAIN RESERVED FOR A SPECIFIC PERIOD ONE YEAR FROM THE DATE OF APPROVAL TO EXERCISE THE SCHEMATIC DRAFT, CONCERNED TO NEGOTIATE WITH THE OWNER AND ALLOCATE THE RESERVED LAND IF REQUIRED FOR THEM AFTER THE SAID PERIOD OF ONE YEAR AND IF NONE OF THE AGENCIES PURCHASE THE RESERVED LAND FULLY, THEN THE LAND OWNER/DEVELOPER IS FREE TO EXERCISE THE SITE RESERVED FOR PUBLIC PURPOSE TO ANYBODY FOR RESIDENTIAL USE ONLY.
  2. DRAIN OF THE SITE TO BE HANDLED AS PER PLAN.
  3. CONDITIONS OF ROAD TO BE FULFILLED.
  4. A WALL ALONG RIVER BANK TO BE CONSTRUCTED TO PROTECT THE MANGROVE FRINGE.
  5. NO SEWERS SHOULD BE LET INTO THE RIVER.
