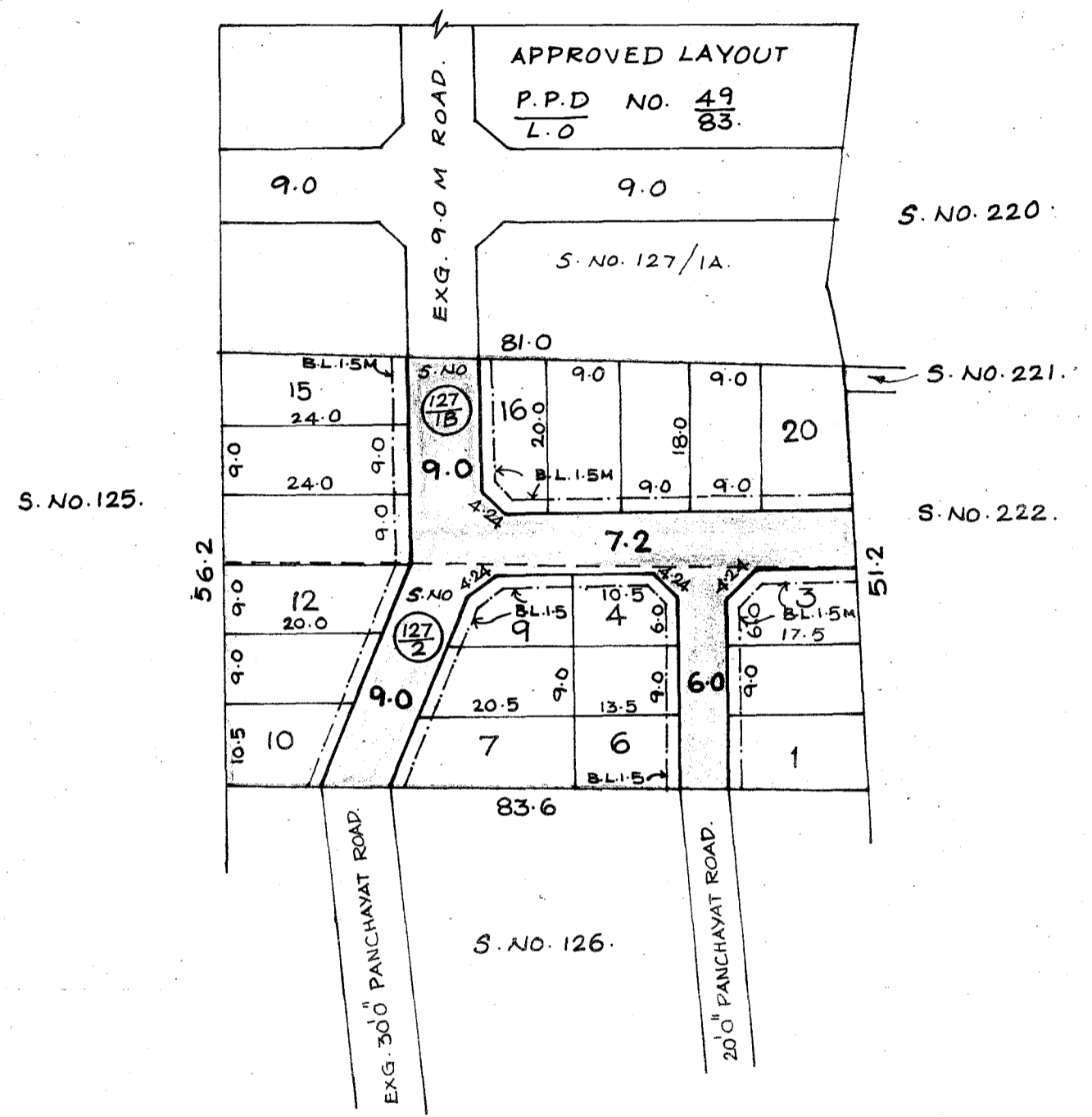

1. WHILE FORMING THE HOUSE SITE THE APPLICANT SHOULD INFORM PWD AND WESTERN SIDE BOUNDARY OF THE LAND NEAR THE FIELD CHANNEL MUST BE MARKED IN THE PRESENCE OF THE OFFICIALS OF PWD.
2. WHILE FORMING LAYOUT OR IN THE FUTURE EXPANSION, THE FIELD CHANNEL SHOULD NOT BE ENCROACHED (OR) OBSTRUCTED AND THE IRRIGATION RIGHTS OF THE RIOTS SHOULD BE PRESERVED, ANY ENCROACHMENT IN THE CHANNEL PORTION WILL BE TREATED AS UNLAWFUL AND WILL BE EVICTED BY THE GOVERNMENT THEN AND THERE.
3. SUITABLE ARRANGEMENTS SHOULD BE MADE BY THE APPLICANT TO DRAW THE RAINWATER WHILE FORMING THE LAYOUT.
4. NO SEWAGE FROM THE DEVELOPED AREA SHOULD BE LET IN TO THE FIELD CHANNEL AND SUITABLE ARRANGEMENT FOR THE DISPOSAL OF THE SAME SHOULD BE MADE BY THE APPLICANT AT THE APPLICANT'S COST.
